

# Comet Transport Group Web Privacy Policy

Comet Transport Group is committed to protecting the privacy of the users of its website. Comet Transport Group is bound by the National Privacy Principles.

Comet Transport Group strives to provide you with a streamlined web experience that delivers relevant services to you in the most efficient way. To this end, Comet Transport Group collects certain information during your use of the Comet Transport Group website.

## What information is collected by Comet Transport Group?

Comet Transport Group may collect the personal information provided by completing online forms on its website, and by occasional email survey and marketing the Comet Transport Group website may undertake from time to time. For example, you may wish to provide us with your contact details so you can be added to our mailing list.

## What information is collected by others?

When you look at the Comet Transport Group website, Comet Transport Group's Internet Service Provider and your Internet Service Provider may also make a record of your visit and collect some or all of the same, or similar, information as the Comet Transport Group websites.

When you follow a link from the Comet Transport Group website to a third-party web site, that website may also make a record of your visit and collect some or all of the same, or similar, information as the Comet Transport Group website. The information collected by any of the third parties is not subject to this Web Privacy Policy. It should be noted that Comet Transport Group has no control over, and does not accept any responsibility for, the privacy and information collection practices of these third parties.

Comet Transport Group will not provide your personal information to other parties external to the Comet Transport Group, simply to enable those parties to target you for marketing, research or any other purposes. If, at any time, Comet Transport Group wishes to share your personal information with other parties, in circumstances other than those described above, we will use our reasonable endeavours to notify you of that intention and to seek your consent before doing so.

## How Comet Transport Group protects your information

Online access to your information and services is protected by your Comet Transport Group username and password which must be provided before you can gain access to your information and services. You should remember that it is your responsibility to you to keep your username and password secret so that they cannot be used by anyone else.

## Use of information collected by Comet Transport Group

Information collected during the ordering process allows us to process and fulfill your service requests and to notify you of your service status.

As well as for fulfilling any requests you may make of Comet Transport Group, the information we collect may be used to keep you informed about new products and initiatives, and also to assist Comet Transport Group in its marketing research and improving the services that we provide.

## Access to information collected by Comet Transport Group

Comet Transport Group will not willfully provide any of the personally identifying information which it has collected about you, or otherwise give access to any of that personally identifying information, to any unrelated third party except where Comet Transport Group believes in good faith:

1. that you have consented; or
2. that the information is required to help identify any abuse or attempt to abuse or compromise the integrity or security of the Comet Transport Group website or any websites connected to them; or
3. that a law enforcement agency, or other government agency, is exercising its legal authority to require Comet Transport Group to provide access to that information.

However, Comet Transport Group may disclose anonymous statistical information to third parties such as advertisers, promoters and partners.

Where services requested by you are performed by a related entity of Comet Transport Group, then your information relevant to the request will be provided to their entity.
